

ASICS 2026 Retro Suite Giveaway – Terms & Conditions

Promoter: Footscray Football Club Limited (ABN 68 005 226 595) of 417 Barkly Street, Footscray, Victoria, 3011, trading as Western Bulldogs.

Type of Promotion: Game of Chance

Promotional Period: Opens Tuesday 2 June 2026 at 9:00 AM AEST and closes Tuesday 9 June 2026 at 9:00 AM AEST. The Promoter may amend the Promotional Period in accordance with state legislative rules.

Eligible Entrants: Entry is free and open to all Victorian residents aged 18+ years or older. Employees of the Promoter, contractors, agents of supplier(s) and sponsors of the Promotion and their immediate families are ineligible to enter. Immediate families means spouse, de facto spouse, parent, child or sibling (whether natural or by adoption) and grandparents.

Entry Procedure: To enter this Promotion, Eligible Entrants must, during the Promotion Period, complete one of the following purchase methods:

Only purchases completed in accordance with one of the above methods, and where the entrant has accepted these Terms and Conditions and the Promoter's Privacy Policy, will be deemed eligible entries into the Promotion.

Maximum Entries: Eligible Entrants may enter once only.

Number of Winner(s): There will be six (6) winners.

Selection of Winner(s): The winning Entries will be picked at random by electronic draw from all the Entries (the Draw). The draw is to take place at 12:00 PM AEST on Tuesday 9 June 2026, at the Promoter's address.
